WHAT

Request for EMERGENCY RELIEF Support on Access to Low Cost Capital Credit/ Grants and Low Cost Green Energy Hydrogen Gas Fuel with Technology Apprenticeship Training!

WHY

The Philadelphia Industrial Development Corporation (PIDC), Philadelphia Gas Works (PGW), Philadelphia Water Department (PWD), and School District of Philadelphia(SDP) are instrumentalities of the City of Philadelphia. PIDC, PGW, PWD, and the SDP have ACCEPTED FEDERAL FUNDING THEREFORE THE ORGANIZATIONS ARE BOUND BY FEDERAL PROTOCOLS IN THEIR OPERATIONS!

ACTION ITEMS

Program proposals have been submitted under Economic Emergency Federal Protocols that would provide to the North and West Philadelphia Business Association Alliance Members Relief on the matters of Philadelphia's economic and environmental support systems that are under duress and/ or collapse, those systems being the energy driven production sectors and the financial sectors. The collapse of these sectors has made fair priced credit and energy more unavailable to the members of the **North and West Philadelphia Business Association Alliance thus creating a going out of business situations for the members of these organizations.** Adequate actual infant industry support for **North and West Philadelphia Business Association Alliance Members has generally not been available with regards to access to capital credit, cheap gas energy and employee apprenticeship training to transition to the world's** new computer age and alternative fuels green hydrogen economy required to prosper in our current economic and social situation.

Our petition documents lay out remedies to these urgent economic and social justice matters that elements of are being requested to be implemented under the Federally Declared Economic Emergency that is represented by the Recovery Act 2009, by PIDC and the other above listed City of Philadelphia Government Instrumentalities. *We are requesting that there begin a written, due process, good faith negotiation for the funding and implementation of these relief programs to be implemented with PIDC, PWD, PGW and the SDP that would provide Emergency Relief to our member constituents in support of their constitutional rights.*

The programs referenced herein address the major streams of Philadelphia's economic/social and environmental support systems that are under duress and/ or collapse those being the energy driven production sectors and the financial support sectors. The energy driven production sectors are addressed by creating a sustainable, affordable non-polluting source of energy and the financial sectors are addressed by creating an institutional-guardian infrastructure (i.e. the individual development account trust agreement [IDATA™] HUMAN DEVELOPMENT FINANCIAL SUPPORT SYSTEM PROTOCOLS) that assures the creation of financial instruments that have integrity of underlying real assets in a manner that mitigates the crowding out effect of government finance, while allowing the rich to keep their wealth

and while at the same time those in need are getting *self-determined access* to financial support that includes low cost capital credit.

The energy driven production sectors are addressed by the creation of energy and communications utility infrastructure via Hydrogen Generation from Electrolysis of Water and Sewage Methane biogas with Apprenticeship Training Programs under the following programs:

- the conversion of vehicles to run alternative fuels to be sited at the AUTOMOTIVE ACADEMY OF WEST PHILADELPHIA HIGH SCHOOL (AAWPHS) Technology Institute Program is an externship open-entry – open-exit program of the CROP™ ACTION TEAM® SBA WPEB BUSINESS HITS™ high intensity technical support program, for our small business participants;
- the Broadcast Technically Trades Apprenticeship Program sited at WPEB 88.1 FM a community radio station the communications HUB organization of the CROP™ ACTION TEAM® SBA WPEB BUSINESS HITS™ high intensity technical support program, with regards to Broadcast Engineering Associate Degree Apprenticeship Program for small businesses in these times of economic changes;
- the Solar and Alternative Energy Technology Building Trades Apprenticeship Technology Institute Program is an externship open-entry – open-exit program of the CROP™ ACTION TEAM® SBA WPEB BUSINESS HITS™ high intensity technical support program, for our small business participants;
- the Conversion of PGW and PWD to Philadelphia Energy and Water Works (PEWW) provides an opportunity to establish green hydrogen technology related trades apprenticeship programs for Philadelphia Resident Ex-offenders to be provided prison-to-work opportunities.

The programs were submitted to the city agencies under emergency procurement protocols, in response to the request of representatives of the President's Administration that the Administration is seeking guidance from urban centers such as Philadelphia on immediate action plans to address the current cost of energy driven Economic Recession/Depression and climatic crisis. Also the designation of Methane Gas by the EPA as a Human Toxin which requires mitigation of methane gas generation and usage activities is included in the packages submitted.

It is to be noted that the City Council of Philadelphia as the over-sight representative organization of the People of Philadelphia has the authority and financial resources to mandate that feasibility studies be funded to implement the conversion of the City of Philadelphia to the green hydrogen based technologies programs herein referenced.
